***PLAY AT OWN RISK.** I have read and understand that ,I am aware that the ball hockey tournament called Hockey For Food is a physical, fast pasted sport and sometimes can accidentally involve contact, also playing ball hockey in a hockey tournament involves many risks, dangers and hazards including, but not limited to: impact and collision with other players, objects or equipment used in connection with playing ball hockey; changes in the type of surface and the condition of the box, including fencing for courts at Saanich Plaza; Victoria, British Columbia, playing with or without officials, with or without first aid attendants. Players play at their Own Risk. Players play with stick and ball and can be hit by the ball as well. Players are encouraged to wear such gear as helmets with cage or visor, mouth guards, neck guard, jocks, chest protector, elbow pads, hockey pants, shin guards, proper shoes blades; all this stated gear is to the responsibility of the player, not Hockey For Food event, Mustard Seed or Topaz Hockey. Also maintaining such gear is to the responsibilities of the player, not Hockey For Food or Mustard Seed or Topaz Hockey. Included in these risks; in no way shape or form the responsibility on the part of the MUSTARD SEED or TOPAZ HOCKEY. Insurance has been purchased. I, the player and signer, freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage, expense and related loss including loss of income, and other loss resulting there from the above mentioned. ***PERMIT.** I understand that the organizers The Mustard Seed and Topaz Hockey hosting the Hockey For Food, will have a permit in their name with Saanich Plaza; the permit will be present to guarantee play at Saanich Plaza on July 13, 2019, the name on the permit has the authority to ask players to leave if they are being unsafe or harmful to any other players. ***INSURANCE.** I understand that Saanich Plaza, Mustard Seed and Topaz Hockey will have insurance during the Hockey For Food event and has paid for insurance. **HAVE FUN, PLAY SAFE, AND HAVE GOOD SPORTSMANSHIP.** I am aware that if failure to play safe will lead to you being asked to leave; failure to safely play within one's own ability; failure to play against others of equal stature or ability in a safe manor; theft, negligence, causing bodily harm with intent to injure other players; we have a coordinator and referees on site which will result in either being asked to leave Hockey For Food at Topaz Park or resulting in being removed from the playing surface by the appropriate authorities. If for some reason you are asked to leave and you choose to not leave, CRD Parks and Recreation and or the authority of Victoria Police will be called to remove you. ***RELEASE OF LIABILITY AND WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.** In participating in HOCKEY FOR FOOD by Mustard Seed and Topaz Hockey during July 13, 2019, organized by Mustard Seed and Topaz Hockey. I hereby agree to the following: ***1. TO WAIVE ANY AND ALL CLAIMS:** I, the signer, have or may in the future have against Mustard Seed and Topaz Hockey during the Hockey For Food event, the right to sue, their representatives and executives, and to release the releases from any and all liability for any loss, damage, injury of expense that I may suffer, or that my next of kin may suffer as a result of my use of or my participation at Hockey For Food event by Mustard Seed and Topaz Hockey due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care. ***2.** This Agreement shall be effective and binding on July 13, 2019 upon my heir(s), next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity. ***3.** This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia. ***4.** Any litigation involving the parties to this agreement shall be brought within the Province of British Columbia. In entering into this Agreement I am not relying upon any oral or written representations or statements made by the releases other than what is set forth in this agreement. I have read and understand this agreement and I the signer am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, assigns and representatives may have against Mustard Seed and Topaz Hockey or Mustard Seed during the Hockey For Food. * All participants under the age of 18 must have waiver signed on their behalf by a parent or legal guardian
